ELIGIBILITY CRITERIA

- ⇒ Women age 40-64
- ⇒ No insurance, under insured
- ⇒ Women age 30-39 with tubal ligation or abnormal Pap smear results (cervical screenings only)
- ⇒ Meet income guidelines (self-report)

MEDICAID TREATMENT PROGRAM

- ⇒ Women under 65
- ⇒ No insurance, under insured
- ⇒ Meet income guidelines (self-report)
- ⇒ Breast or cervical cancer diagnosis through biopsy

Updated Reimbursement Rates and Income Guidelines Effective February 1, 2017

The new Medicare rates for ABCCEDP services are updated and are available on the ABCCEDP website. Attached are the new reimbursement rates, effective February 01, 2017. Mammogram procedure codes, 77057, 77056 and 77055 are not approved procedure codes after January 31, 2017. The new mammogram procedure codes that replaced 77057, 77056 and 77055 are 77067, 77066 and 77065. Since Medicare does not have reimbursement rates for these codes, CDC has advised ABCCEDP to use digital mammogram rates for these codes.

Updated Income Guidelines to determine income eligibility are also available on our website and featured in this fact sheet.

ABCCEDP Contract Renewals

ABCCEDP Contract renewals will begin to go out in February 2017. The contract renewal will cover services provided June 30, 2017–June 29, 2019. The current ABCCEDP contract ends in June 29, 2017. You will receive more information from your Regional Coordinator.
