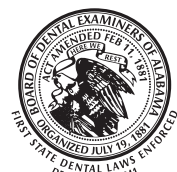

### **Bobbi Jo Beverly**

#### **University of Alabama at Birmingham**

Bobbi Jo Beverly has been employed as a certified Peer Specialist with UAB Substance Abuse Programs and the Family Wellness Program since March of 2016, and has a personal clean date of October 11, 2013. Mrs. Beverly was a participant in the Family Wellness Program, and has gone on to become a vital member of the case management team.

Mrs. Beverly holds a Bachelor's of Science Degree from The University of Central Florida, and is a Certified Recovery Support Specialist through the Alabama Department of Mental Health. Mrs. Beverly is an active member of the leadership team at Celebrate Recovery with ONEighty Church in Springville, Alabama, and has also been appointed to the Alabama Governor's Opioid Overdose and Addiction Council.

### **Dr. Susanne Astrab Fogger, DNP, CRNP, PMHNP-BC, CARN-AP, FANNP**

#### **Professor University of Alabama at Birmingham, School of Nursing**

Dr. Susanne Fogger teaches psychiatric and addictions nursing across the curriculum within the University of Alabama at Birmingham (UAB), School of Nursing. She has integrated Veteran centric mental healthcare to prepare students to care for diverse populations. Dr. Fogger's ongoing clinical experience includes her scholarship in care to individuals with HIV, substance use disorders, and mental illness. Within her practice Dr. Fogger supervises graduate students whose practice offers a focus on psychosocial issues in patients living with HIV. She has been recognized by the American Association of Nurse Practitioners as a Fellow in 2015, and was elected as Treasurer to the Board of Directors of the International Nurses Society on Addictions. In addition, she is on the Editorial Board of the Journal of Addictions Nursing. Dr. Fogger is currently the Professor of the UAB School of Nursing.

### **Ann Slattery DrPH, RN, RPh, DABAT**

#### **Alabama Regional Poison Control**

Dr. Ann Slattery graduated from Samford University with both Nursing and Pharmacy degrees. She graduated from the University of Alabama at Birmingham (UAB) with her MPH and DrPH in Environmental Health/Toxicology. She completed her Fellowship at the Centers for Disease Control and Prevention, Agency for Toxic Substances and Disease Registry in 1995. Dr. Slattery has worked for 36 years in the Regional Poison Control Center and is currently the Director. She is a certified specialist in poison information (CSPI) and a Diplomat of the American Board of Applied Toxicology (DABAT—boarded clinical toxicologist). She serves as an Adjunct Professor at the McWhorter School of Pharmacy for 10 years teaching the toxicology elective, as an Editor for Lexicomp since 2007, and an Expert Reviewer for the American College of Clinical Pharmacy.

### **Stephen Taylor, MD, MPH**

Dr. Stephen Taylor is board-certified in general psychiatry, child and adolescent psychiatry, addiction psychiatry, and addiction medicine. In his 24 years of practice experience, and as a sought-after speaker, educator, and presenter for audiences all over the country, Dr. Taylor's life's work and greatest passion has been to help teenagers and adults avoid or overcome the scourge of alcohol, drug abuse, and addiction. Dr. Taylor has served for 11 seasons as the Medical Director for the Player Assistance and Anti-Drug Program of the National Basketball Association and the National Basketball Players Association. Dr. Taylor also serves as the Chief Medical Officer of the Behavioral Health Division of Pathway Healthcare, where he is an integral part of Pathway's mission to open and operate outpatient addiction treatment offices in Texas, Louisiana, Mississippi, Tennessee, and Florida, as well as three offices in Alabama – one of which is in Birmingham. Dr. Taylor is also a certified Medical Review Officer, and is a member of the Board of Directors of the Medical Review Officer Certification Council. He is a Fellow of the American Society of Addiction Medicine, and is also a member of the American Psychiatric Association, the American Academy of Child and Adolescent Psychiatry, and the American Academy of Addiction Psychiatry. Dr. Taylor has also served on the Board of Directors of All-In Mountain Brook.

An honors graduate of Harvard College, with a Master's Degree from the Harvard School of Public Health, and a Medical Degree from Howard University College of Medicine, Dr. Taylor, and his wife of 30 years, Dr. Angela Taylor, have two children; Nia, age 28, and Jamal, age 25, who, like their mother, are alumni of the University of Pennsylvania.

### **Brent Boyett, DMD, DO**

#### **Chief Medical Officer and Founder of Pathway Healthcare, LLC**

Dr. Brent Boyett was trained as a general dentist and is board-certified in Family Medicine as a physician. He practiced both dentistry and primary care medicine until he discovered his passion in the field of Addiction Medicine in 2008. He became board-certified in Addiction Medicine by the American Board of Preventative Medicine and has distinguished himself as a speaker, researcher, and thought leader in the field of Addiction Medicine.

As a researcher, Dr. Boyett has served as principle investigator in several clinical trials, and has also served as a clinical advisor for the pharmaceutical industry, aiding in the development of new treatment options for addictive disorders.

He is a public speaker dedicated to the effort of educating the healthcare community and the public-at-large on the disease model of substance use disorders, and to help remove the stigma of addiction.

Dr. Boyett is a former president of the Alabama Osteopathic Medical Association and the current president of the Alabama Society of Addiction Medicine (ALSAM). In his role as ALSAM president, his top priorities include the effort to fully implement Parity Law, and to bring addiction medicine into the mainstream of the healthcare system ultimately improving access to care for patients in need.

In 2017, Dr. Boyett was appointed by Alabama Governor Robert Bentley to serve on the Governor's Task Force on Opioid Addiction and Abuse. This committee is made up of leaders from the state's criminal justice system, public, and mental health systems and medical profession with the assignment of combating Alabama's opioid abuse crisis.

In 2018, Dr. Boyett was recognized as a Distinguished Fellow by the American Society of Addiction Medicine.

### **Morissa Ladinsky, MD**

#### **University of Alabama at Birmingham, Department of Pediatrics**

Dr. Morissa Ladinsky is an Associate Professor of Pediatrics at the University of Alabama at Birmingham (UAB) in the Division of General Pediatrics and Adolescent Medicine. She attended Brown University and Baylor College of Medicine. Dr. Ladinsky completed her pediatric residency at Texas Children's Hospital, and a Fellowship in General Academic Pediatrics at Johns Hopkins Hospital. She has held faculty positions at Sinai Hospital of Baltimore, The Ohio State University/ Nationwide Children's Hospital, and Cincinnati Children's Hospital. Dr. Ladinsky is also a "fluid academic" and has had extensive front line experience in general pediatric practice working in Houston, Baltimore, and Cincinnati. Her particular passion is providing primary care for youth with complex medical and behavioral conditions. More than ever, as a full-time faculty member at UAB and Children's of Alabama, she is committed to improving health outcomes for children with chronic conditions, LGBTQ-identified youth, substance exposed infants, and teaching the next generation of front line providers while addressing health care disparities and equal access for all.

### **Lorie Harper, M.D.**

#### **Associate Professor, University of Alabama at Birmingham, Maternal/Fetal Medicine**

Dr. Lorie Harper currently serves as an Associate Professor at the University of Alabama at Birmingham, and works in the Department of Obstetrics and Gynecology, Division of Maternal-Fetal Medicine. Her focus of research has been to optimize pregnancy outcomes in medically complicated pregnancies. The specific focuses are relating to complicated pregnancies caused by substance use disorders, obesity, diabetes, and hypertension.

Ms. Muir has worked with the Jefferson County Family Wellness Court since its inception, and recently launched the Comprehensive Addiction in Pregnancy Program in partnership with UAB's Maternal-Fetal Medicine.

### **Shereda Finch, MEd, MPA**

#### **Executive Director, Council on Substance Abuse**

Shereda Finch has been the executive director at the Council on Substance Abuse-NCADD (COSA-NCADD) for 5 years. Originally from Cleveland, Ohio, Ms. Finch has worked in the non-profit arena over 20 years. Since joining COSA-NCADD, she has led the organization in expanding alcohol and substance/HIV prevention programs and recovery support services to six additional counties in Alabama.
